<u>Pre-Arbitration Dispute Resolution</u>: Thailand Commercial is always interested in resolving disputes amicably and efficiently, and most customer concerns can be resolved quickly and to the customer's satisfaction by emailing customer support at support@Thailand Commercial.com.

<u>Arbitration Procedures:</u> Arbitration will be conducted by a neutral arbitrator in accordance with the laws of the Kingdom of Thailand. If there is any inconsistency between any term of the law and any term of this Arbitration Agreement, the applicable terms of this Arbitration Agreement will control unless the arbitrator determines that the application of the inconsistent Arbitration Agreement terms would not result in a fundamentally fair arbitration. The arbitrator must also follow the provisions of these Terms of Service as a court would. All issues are for the arbitrator to decide, including, but not limited to, issues relating to the scope, enforceability, and arbitrability of this Arbitration Agreement. Although arbitration proceedings are usually simpler and more streamlined than trials and other judicial proceedings, the arbitrator can award the same damages and relief on an individual basis that a court can award to an individual under the Terms of Service and applicable law. Decisions by the arbitrator are enforceable in court and may be overturned by a court only for very limited reasons. Unless Thailand Commercial and you agree otherwise, any arbitration hearings will take place in Bangkok, Thailand. Regardless of the manner in which the arbitration is conducted, the arbitrator shall issue a reasoned written decision sufficient to explain the essential findings and conclusions on which the award is based.

<u>Confidentiality:</u> All aspects of the arbitration proceeding, and any ruling, decision, or award by the arbitrator, will be strictly confidential for the benefit of all parties.

<u>Severability</u>: Without limiting the severability provision in this section of the Terms of Service, if a court or the arbitrator decides that any term or provision of this Arbitration Agreement other than the Prohibition of Class and Representative Actions and Non-Individualized Relief section above is invalid or unenforceable, the parties agree to replace such term or provision with a term or provision that is valid and enforceable and that comes closest to expressing the intention of the invalid or unenforceable term or provision, and this Arbitration Agreement shall be enforceable as so modified.

Termination

You agree that Thailand Commercial, in its sole discretion, may suspend or terminate your account (or any part thereof), deactivate any part, block your email or IP address, or remove and discard any content within the Service, for any reason, including, without limitation, for lack of use or if Thailand Commercial believes that you have violated or acted inconsistently with the letter or spirit of these Terms.
